The Stop Work Policy instituted by the company promotes more significant involvement of the employees in terms of Workplace Health and Safety, increases the workers' awareness of Safety, encourages collaboration between co-workers, promotes greater communication between co-workers and supervisors, and guarantees a safe work environment.
